PROCEDURES AND INSTRUCTIONS

Provision of Law:

Section 320.0607, Florida Statutes, provides for the replacement of license plates and validation decals when the original license plate or decal has been lost, stolen, defaced, damaged or lost in transit.

Application Requirements:

1. Application for replacement of registration license plates, validation decals or parking permits must be processed by the local county license plate agency or the Division of Motor Vehicles.
2. Form HSMV 83146, Application For Replacement License Plate, Validation Decal, or Parking Permit must be completed in detail and signed by the owner or lessee.
3. Fees required are indicated in Section 1 on the reverse side of this form.
4. A copy of the Florida vehicle registration certificate should be submitted for verification purposes.

The Division of Motor Vehicles will provide for the following types of replacement:

Voluntary Replacement of License Plate at time of Renewal:

An owner may, at any time during the registration period, replace a license plate, decal or parking permit through any Tax Collector or license plate agent. The replacement license plate fee is required in addition to the regular registration renewal fee, if the plate has expired.

Defaced or Damaged:

If a law enforcement officer issues a citation for a defaced or damaged license plate, the owner must surrender the license plate to a Tax Collector or License Plate Agent and purchase a replacement. If an owner deems their license plate defaced or damaged they may request a replacement license plate at the time of renewal. A replacement fee is required.

Lost in Transit:

Applications for replacement of a license plate, decal or parking permit that has been lost in transit must be processed in the county that originally processed the transaction. **EXCEPTION:** The lost in transit may be replaced by another county if the original county will fax a copy of the registration (indicating the original transaction was mailed) to the county that is issuing the replacement. License plates, decals or parking permits lost in the mail may be replaced at no additional fee if application is made within 180 days from date of issue.

Stolen License Plates:

Applications for replacement of a stolen license plate, decal, or parking permit may be submitted to any Tax Collector or License Plate Agent. If the application for replacement is for a temporary license plate, it must be submitted to the Tax Collector or license agency where it was originally issued. The replacement of "special license plates" not issued in the Tax Collector's office must be submitted to the Division of Motor Vehicles. The applicant must certify in Section 4 that the item was reported to law enforcement as being stolen.

Surrendered or Seized:

Applications for replacement of surrendered or seized license plates or parking permits must include Form HSMV 74079 completed by the Division of Driver License stating the owner was in compliance with the law at the time of suspension of driver license.
