Call to Order

<u>Selection of Vice-Chairman</u> – Mr. Parker nominated Mr. Posey as Vice-Chairman. Mr. McGill seconded. Motion carried.

<u>Selection of Secretary</u> – Mr. Sammons recommended Jaime Bolden to be the Secretary of the Board for 2023. Mr. Parker motioned that Ms. Bolden be Secretary for 2023, Mr. Posey seconded. Motion carried.

Report of the Chief Appraiser
