## **Call to Order**

Chairman, Dravian McGill, Sr., called the meeting to order at 8:00 a.m.

**Approval of Minutes** – The minutes of the March 8, 2023 and April 5, 2023 Board Meetings were presented. Mr. Turner then made a motion to approve the minutes. Mr. Posey seconded. Motion carried.

## **Appeals**

**Motor Vehicle Appeals** – Mr. Sammons presented seven vehicle appeals to the Board. Mr. Parker made a motion to approved the appeals. Mr. Turner second. Motion carried.

**Homestead Exemptions** – Mr. Sammons presented two S5 and one S1 homestead applications. A motion was made by Mr. Turner to approve the two S5 applications and deny the one S1 application. The denial was made on the grounds of different ownership of land and mobile home, Mr. Parker second. Motion carried.

**CUVA Applications** – Mr. Sammons presented 3 CUVA applications to the Board. A motion was made by Mr. Parker to approve 2 CUVA applications and deny 1 application on the grounds of the application was made and signed by someone without the requested Letter of Authorization. Mr. Turner second. Motion carried.

**Freeport Applications** – Ms. Bolden presented 3 Freeport applications for approval. A motion was made by Mr. Turner to approve the 3 Freeport applications. Mr. Parker seconded. Motion carries.

**Exempt Property Application** – Mr. Sammons presented an exempt property application from International Tribal Ministries, Inc. Mr. McGill tabled for vote pending further information.

**Notice of Assessments** – Mr. Sammons presented information regarding the 2023 Notice of Assessments. Mr. Turner made a motion to print and mail the 2023 Real Property Notice of Assessments on May 15th. Mr. Posey seconded. Motion carried.
