## INSTRUCTIONS AFFIDAVIT FOR HOMESTEAD APPLICATIONS PROPERTIES CONVEYED TO A TRUST

Per O.C.G.A. § 48-5-54, "[Homestead] exemptions shall also extend to those homesteads the title to which is vested in an administrator, executor, or trustee if one or more of the heirs or cestui que uses residing on such property claims the exemption in the manner provided by law." It is often difficult for the Office of the Tax Commissioner or the Board of Tax Assessors to determine the "cestui que uses," or beneficiaries, of a trust who reside on a parcel. This affidavit provides a means for persons to identify the beneficiaries of a trust, so that the Office of the Tax Commissioner and the Board of Tax Assessors have certainty as to who may apply for a homestead tax exemption under Georgia law.

The only persons who should complete this affidavit are the following: (1) a trustee who has personal knowledge regarding the trust, including the identities of the persons who are beneficiaries and trustees of the trust; (2) a beneficiary who has personal knowledge regarding the trust, including the identities of the persons who are beneficiaries and trustees of the trust; or (3) an attorney who has personal knowledge regarding the trust (generally the attorney who prepared the trust documents), including the identities of the persons who are beneficiaries and trustees of the trust.

Please completely fill out the affidavit and sign the affidavit in the presence of a notary public. Only complete affidavits signed in the presence of a notary public will be accepted. Please note that this affidavit will be kept on file. Submission of this affidavit does not guarantee approval of homestead status, and the Office of the Tax Commissioner and the Board of Tax Assessors may further examine an application as necessary to ensure that all other prerequisites are satisfied for the grant of homestead status under Georgia law.
