- Judges, including: Justices of the Supreme Court, District Court of Appeal Judges, Circuit Court Judges, County Court Judges, Current or former Judges of the United States Courts of Appeal, United States District Judges and United States Magistrate Judges
- Current or former State Attorneys, Assistant State Attorneys, Statewide Prosecutors, or Assistant Statewide Prosecutors
- Current or former County and Municipal Code Inspectors and Code Enforcement Officers
- General Magistrates, Special Magistrates, Judges of Compensation Claims, Administrative Law Judges of the Division of Administrative Hearings and Child Support Enforcement Hearing Officers
- Current or former United States Attorneys and Assistant United States Attorneys
- Current or former Guardians Ad Litem, as defined in S.39.820
- Current or former Juvenile Probation Officers and other personnel of the Department of Juvenile Justice.
- Certain personnel of any local government agency or water management district whose duties include hiring and firing employees, labor contract negotiation, administration or other personnel-related duties.
- Spouse and children of all of the above.
