**Assessors' Meeting

Chief Appraiser's Report**

1. Our 45-day appeal deadline passed on July 1. Currently there are 243 parcels of real property under active appeal or still under a 30-day change notice. The total value in dispute is \$7,240,092. We have no BOE appeals at present.
2. We received three bids for Cadastral mapping. These will be reviewed and discussed at this meeting. Decisions will be documented in the minutes.
3. No word from the BOC on the salary budget. Bryan Aasheim and Kendall Gross are aware that I will be out on short-term disability for two separate surgeries before July 1, 2020. Those absences will balance the budget with no further changes. Kendall recommends the BOA and I attend the July 15<sup>th</sup> meeting of the BOC.
