Assessors' Meeting March 12, 2019 Chief Appraiser's Report

- 1. The housing cost analysis shows the cost per square foot needs to be increased from \$50.00 to \$59.00. See attached spreadsheet and new ratio study of Improved Residential (R1) properties.
 - a. RES: Median 0.4043; AGG 0.3933; COD 0.0640 PRD 1.0208
- 2. The Schneider/qPublic contract renewal has been approved and signed.
- 3. Chris Kight has finished entering all the changes and pictures for the parcels reviewed.
- 4. Steve Pohlmann has finished our splits and map work for 2018. The new parcels have been loaded on the website also.
- 5. I met with Kendall Gross about the Pulaski City Zoning Ordinance and Mobile Home Ordinance which has our office performing inspections and issuing permits. Kendall responded in writing that our office should not do anything pertaining to permits or inspections in the City of Pulaski without an intergovernmental agreement between them and the County. He also wrote to Brent Carter their attorney, about doing an intergovernmental agreement.
- 6. Our GIS professional services is over budget by \$1,650.00 due to the predisaster mitigation project that I pulled Steve Pohlmann in on. I have talked to him about this and our 2020 budget of \$8,800. He has made suggestions how we can cut our cost if the Commissioners will require a digitized copy of the plats when they approve them. I intend to present this to Bryan at our April meeting of managers.
