Chief Appraisers Status Report

July 11, 2023

1. Mobile home inspections came to a halt for a week and a half due to the truck being in the shop.
2. Budget was approved and passed by the Board of Commissioners with a cost-of-living increase to both full time hourly employees, and an increase of \$500 to the office supply budget.
3. Marian has been in the office twice since the last meeting to assist with Splits. I'll be calling her in again shortly to assist with more splits once they're all identified through deed work training with Ronda.
4. APPEALS STATISTICS:
 - 142 Appeals are currently under their 30-Day status with 3.5 mil under appeal
 - 271 Appeals are currently in process of being reviewed with 7.9mil under appeal
 - 24 Appeals have been resolved by passing their 30-Day status with no continuation to the Board of Equalization
 - That leaves a total of 437 Appeals filed, with a total of 11.5mil under appeal
 - Comparable years would be 2007 with 344 appeals and 45.76 mil under appeal, 2014 with 395 appeals and 43.87 mil under appeal, though the appeal count is relatively high, the value under appeal is not.
 - 6% of the digest is under appeal right now, and it will need to be below 3% for the final digest to be approved by the state.


