## **Chief Appraisers Status Report**

June 13, 2023

- 1. Notice of Assessments were mailed out on May 23, which makes our appeals deadline July 7th.
- 2. As of today, 48 real property appeals have been processed with new notices being sent to taxpayers. 15 appeals are currently on my desk waiting to be processed, some require a field review. With 25 days left in the appeals period, we have not yet had any appeals escalated to the Board of Equalization.
- 3. Mrs. Childs and myself attended CAVEAT last month.
- 4. Both full time workstations have received new computers. After a small repair on the computer assigned to personal property, everything seems to be running smoothly.
- 5. I have reviewed and made changes to the process we use to bring a mobile home into the county based on the newly approved Manufactured Home Location Permit Ordinance approved by the Board of Commissioners. (attached)
- 6. I have created a checklist to streamline the Motor Vehicle Appeals Process so that it is easier to digest for taxpayers, after receiving a complaint that it was difficult to understand. (attached)
- 7. The map printer was not operating earlier in the month. I used the error code and some research to diagnose the problem. We had to order a new printer head in the amount of \$424 dollars, but saved around \$300 by diagnosing the problem and replacing the part ourselves.
- 8. Part-time employee has only been to the office once in the last month in the amount of around 8 hours. I'll be calling her to come and assist with splits and some appeals before the end of June.
- 9. A backup camera has been installed on the truck.
- 10. Newest employee is settling in well, and training with deed work has already begun.
