## COFFEE COUNTY BOARD OF COMMISSIONERS REGULAR MEETING APRIL 15, 2019 9:30 O'CLOCK A.M. COMMISSIONERS' MEETING ROOM

Coffee County Board of Commissioners met in regular session on Monday, April 15, 2019, at 9:30 o'clock a.m. with the following present: Chairman Jimmy Kitchens, Vice-Chairman Johnny Wayne Jowers, Commissioners AJ Dovers, and Oscar Paulk. Also present were County Attorney Tony Rowell, and County Clerk Tracie Vickers. Commissioner Charles Deen and County Administrator Wesley Vickers was absent.

Chairman Kitchens called the meeting to order and welcomed everyone. Commissioner Jowers asked County Attorney Tony Rowell to give the invocation. Everyone participated in the pledge of allegiance to the flag of the United States of America.

Chairman Kitchens asked if there were any announcements. There were no announcements.

Chairman Kitchens asked for approval of the minutes of the pre-meeting work session and regular meeting held on April 1, 2019 and the special called work session and executive session held on April 9, 2019. Commissioner Jowers made a motion to approve the minutes. Commissioner Paulk seconded the motion. All Commissioners unanimously agreed.

Chairman Kitchens asked for approval of the agenda. Commissioner Dovers made a motion to approve the agenda. Commissioner Jowers seconded the motion. All Commissioners unanimously agreed.

County Attorney Rowell discussed the supplemental agreement between Coffee County and State of Georgia Department of Transportation for CR 705 Bridgetown Road at Satilla River 11 miles West of Douglas. Attorney Rowell stated this bridge was on the list and approved in August 2018 at the Regular Meeting for a contributing amount by the County of \$103,000.00. The Department of Transportation has moved this to a new funding cycle for 2019 which has enabled them to set a new contributing amount of \$50,000.00. This is ready for approval today. Chairman Kitchens asked for a motion to approve or reject the supplemental agreement No. 1 between Coffee County and State of Georgia Department of Transportation for CR 705 Bridgetown Road at Satilla River 11 Miles West of Douglas. Commissioner Jowers made a motion to approve this supplemental agreement. Commissioner Paulk seconded the motion. All Commissioners unanimously agreed.

County Attorney Rowell stated that Mr. George Gillis has made an application to close Broken Arrow Road. This road closure has been advertised in the newspaper and is ready for a public hearing. Chairman Kitchens asked for a motion to open the public hearing. Commissioner Dovers made a motion to open the public hearing. Commissioner Paulk seconded the motion. All Commissioners unanimously agreed. Mr. George Gillis stated he would like to close this road to install a pivot. There were no further comments from the audience.
