COMMISSIONERS' MEETING ROOM

Coffee County Board of Commissioners met in regular session on Monday, February 4, 2019, at 9:30 o'clock a.m. with the following present: Chairman Jimmy Kitchens, Vice-Chairman Johnny Wayne Jowers, Commissioners AJ Dovers, and Oscar Paulk. Also present were County Attorney Tony Rowell, County Administrator Wesley Vickers and County Clerk Tracie Vickers. Commissioner Charles Deen was absent.

Chairman Kitchens called the meeting to order and welcomed everyone. Commissioner Jowers asked County Attorney Tony Rowell, to give the invocation. Everyone participated in the pledge of allegiance to the flag of the United States of America.

Chairman Kitchens asked if there were any announcements. There were no announcements.

Chairman Kitchens asked for approval of the minutes of the pre-meeting work session and regular meeting held on January 22, 2019. Commissioner Paulk made a motion to approve the minutes. Commissioner Jowers seconded the motion. All Commissioners unanimously agreed.

Chairman Kitchens asked for approval of the agenda. Commissioner Dovers made a motion to approve the agenda. Commissioner Paulk seconded the motion. All Commissioners unanimously agreed.

County Attorney Rowell read the Proclamation for FCCLA Week February 10 -16. Several members of the Coffee High School FCCLA chapter were present.

Chairman Kitchens asked for a motion to approve the Proclamation for FCCLA Week. Commissioner Dovers made a motion to approve the Proclamation. Commissioner Jowers seconded the motion. All Commissioners unanimously agreed.

Chairman Kitchens asked for a motion to approve or reject the appointment of a Board Member to the Planning and Zoning Commission Board for the term expiring June 30, 2019. Commissioner Jowers made a motion to appoint Mr. Marvin Knight to the Planning and Zoning Board. Commissioner Paulk seconded the motion. All Commissioners unanimously agreed.

County Administrator Vickers stated the County has received a petition from Mr. Clifford Kirkland to close Villa Street. The portion of the road to be closed will begin at its intersection with Lacey Avenue and traveling Southeast to its intersection with a closed road formerly known as Merritt Lane. The length of the road to be closed is approximately 250 feet. Ms. Janine Hutchison, that owns property bordering this road, has also asked for this road to be closed. Letters have been sent out to adjacent land owners and this has been advertised in the newspaper. Chairman Kitchens asked for a motion to enter into a public hearing for the road closure for Villa Street. Commissioner Jowers made a motion to enter into a public hearing. Commissioner Dovers seconded the motion. All Commissioners unanimously agreed. There were no public comments. Chairman Kitchens asked for a motion to close the public hearing. Commissioner Jowers made a motion to close the public hearing. Commissioner Paulk seconded the motion. All Commissioners unanimously agreed.

Chairman Kitchens asked for a motion to approve or reject the Resolution for Road Closure of Villa Street. Commissioner Jowers made a motion to approve the Resolution. Commissioner Dovers seconded the motion. All Commissioners unanimously agreed.

Chairman Kitchens asked for any comments from the audience. There were no comments from the audience.

Chairman Kitchens asked for a motion to adjourn the Regular Meeting. Commissioner Paulk made a motion to adjourn the meeting at 9:44 a.m. Commissioner Jowers seconded the motion. All Commissioners unanimously agreed.
