COMMISSIONERS' MEETING ROOM

Coffee County Board of Commissioners met in regular session on Monday, October 21, 2019, at 9:30 o'clock a.m. with the following present: Chairman Jimmy Kitchens, Vice-Chairman Johnny Wayne Jowers, Commissioners AJ Dovers, Oscar Paulk and Ted O'Steen. Also present were County Attorney Tony Rowell, Deputy County Clerk Abby Paulk and County Administrator Wesley Vickers.

Chairman Kitchens called the meeting to order and welcomed everyone. Commissioner Dovers asked County Fire Chief Steve Carver to give the invocation. Everyone participated in the pledge of allegiance to the flag of the United States of America.

All Commissioners unanimously agreed.
