Coffee County Board of Commissioners met in regular session on Monday, October 4, 2021, at 9:35 o'clock a.m. with the following present: Chairman Oscar Paulk, Vice-Chairman AJ Dovers Commissioners Jimmy Kitchens, Ted O'Steen and Johnny Wayne Jowers. Also, present were County Attorney Tony Rowell, County Administrator Wesley Vickers, and Deputy Clerk Abby Paulk. Also, present were Agency Directors/Department Heads, the media, and members of the public.

Chairman Paulk called the meeting to order and welcomed everyone. Commissioner Jowers asked County Attorney Tony Rowell to give the invocation. Everyone participated in the pledge of allegiance to the flag of the United States of America.

There were no announcements.

Chairman Paulk asked for a motion to approve the minutes of the pre-meeting work session and the regular meeting held on September 7, 2021 and the Executive session held on August 26, 2021 and the Executive Session held on September 7, 2021. Commissioner Kitchens made a motion to approve the minutes. Commissioner Jowers seconded the motion. All Commissioners unanimously agreed.

Chairman Paulk asked for a motion to approve the agenda. Commissioner Dovers made a motion to approve the agenda. Commissioner O'Steen seconded the motion. All Commissioners unanimously agreed.

Chairman Paulk asked for a motion to approve or reject the appointment of a 2021 voting Delegate on behalf of Coffee County for the 2022 Legislative session. Commissioner Kitchens made a motion to appoint Chairman Paulk to this position. Commissioner Jowers seconded the motion. All Commissioners unanimously agreed.

Ms. Chalanda Woods, County 4-H Program Assistant, thanked the Commission for their support of the local 4-H program. Several members of Coffee County 4-H shared their many experiences throughout the years that they have enjoyed. County Attorney Rowell read the Proclamation for National 4-H week October 3-9, 2021. Chairman Paulk asked for a motion to approve the Proclamation. Commissioner Jowers made a motion to approve the Proclamation. Commissioner Kitchens seconded the motion. All Commissioners unanimously agreed.

Chairman Paulk asked for a motion to approve or reject the Resolution authorizing the filing of an application with Georgia Department of Transportation and the United States Department of Transportation assistance under Title 49 U.S.C Section 5311 authorizing Southern Georgia Regional Commission to be the designated agency to execute the Grant. Commissioner O'Steen made a motion to approve the Resolution. Commissioner Dovers seconded the motion. All Commissioners unanimously agreed.

County Administrator Vickers reviewed the bids for the purchase of a van for the 4-H program. The bids received were for a 2022 High Roof Ford Transit Van with rear dual wheels. Mr. Vickers stated the van is costing more due to the dual tires on the back for the safety of children. The bids received were from the following:

Commissioner Osteen made a motion to approve the bid from Anderson Ford for \$43,847.76. Commissioner Jowers seconded the motion. All Commissioners unanimously agreed.
