COMMISSIONERS' MEETING ROOM

Coffee County Board of Commissioners met in regular session on Monday, September 17, 2018, at 9:30 o'clock a.m. with the following present: Chairman AJ Dovers, Vice-Chairman Charles Deen, Commissioners Jimmy Kitchens, Johnny Wayne Jowers and Oscar Paulk. Also present were County Attorney Tony Rowell, County Administrator Wesley Vickers and County Clerk Tracie Vickers.

Chairman Dovers called the meeting to order and welcomed everyone. Commissioner Jowers asked County Attorney Tony Rowell to give the invocation. Everyone participated in the pledge of allegiance to the flag of the United States of America.

Chairman Dovers announced the Joint City, County, Board of Education Meeting will be held on Tuesday, September 18th at 6:00 p.m. at the C.E. Weir Center.

Chairman Dovers asked for approval of the minutes of the pre-meeting work session and regular meeting held on September 4, 2018. Commissioner Jowers made a motion to accept the minutes. Commissioner Paulk seconded the motion. All Commissioners unanimously agreed.

Chairman Dovers asked for approval of the agenda. Commissioner Deen made a motion to approve the agenda. Commissioner Kitchens seconded the motion. All Commissioners unanimously agreed.

County Attorney Rowell read the Proclamation for 2018 Passionately Pink Day on October 25, 2018. Ms. Lorna Hurst thanked the Commission for their continued support of Breast Cancer Awareness. Chairman Dovers asked for a motion to accept the Proclamation proclaiming October 25, 2018 as Passionately Pink Day in Coffee County. Commissioner Kitchens made a motion to accept this Proclamation. Commissioner Deen seconded the motion. All Commissioners unanimously agreed.

Chairman Dovers asked for a motion to appoint Mr. Vernon Talkington to the Coffee County Board of Health for the term of September 17, 2018 through December 31, 2021 due to the resignation of Ms. Ann Carver. Commissioner Jowers made a motion to appoint Mr. VernonTalkington to the Board of Health. Commissioner Paulk seconded the motion. All Commissioners unanimously agreed.

County Administrator Vickers stated we are submitting 14,528 miles of roads for the 2019 LMIG Project. The total estimated cost of this project is \$2,500,497.27. LMIG proceeds should be approximately 1.2 million dollars and the remainder will be funded through SPLOST funds. This is ready for approval today. Chairman Dovers asked for a motion to approve or reject the submission of the 2019 LMIG Application to Georgia Department of Transportation. Commissioner Kitchens made a motion to accept this application. Commissioner Deen seconded the motion. All Commissioners unanimously agreed.

Chairman Dovers asked for any comments from the audience. There were no comments from the audience.

Chairman Dovers asked for a motion to adjourn the Regular Meeting. Commissioner Deen made a motion to adjourn the meeting at 9:40 a.m. Commissioner Jowers seconded the motion. All Commissioners unanimously agreed.
