Board of Assessors Meeting Minutes September 6, 2016

1. MEETING CALLED TO ORDER BY THE BOARD OF TAX ASSESSORS

The meeting was called to order by Vice-Chairman Dan Coffee at 4:33pm at the Tax Annex. A quorum was present including the following: Daniel B. Coffee, Jon G. Hale, Jr. Leticia A. Cook entered at 4:40pm, and Lauren A. Harbin, Secretary.

Vice-Chairman Coffee welcomed new Board member Jon Hale to the Board of Assessors. Mr. Hale stated that he was glad he was able to serve and the he completed his 40 hours of training the previous week.

Ms. Cook motioned to amend the agenda to elect officers for the remainder of the 2016 year. Vice-Chairman Coffee seconded the motion. There was no further discussion the motion passed 2-0-0.

Ms. Cook made a motion to elect Dan Coffee Chairman and Jon Hale Vice-Chairman. Mr. Hale seconded the motion. There was no further discussion. Motion Carried 2-0-0.

2. Approval of minutes

- a. A motion was made by Ms. Cook to approve the minutes from the regular monthly meeting on August 2, 2016. Vice-Chairman Coffee seconded the motion, there was no further discussion. The motion carried 2-0-0. Mr. Hale did not vote since he was not in attendance at the August meeting.

 - A. Quentin Leonard Appraiser II Certification- Mrs. Harbin informed the Board that Mr. Leonard successfully completed his Appraiser II examination. Vice-Chairman Coffee added that a memo was sent to the Board Of Commissioners requesting his 7.5% salary increase pursuant to Board policy upon completion of a new certification level.

A motion was made to approve the Error and Release forms by Mr. Hale, and Ms. Cook seconded the motion. There was no further discussion. So Carried 2-0-0.

- E. Appeal Update Mrs. Harbin informed the Board that appeal hearings began last week.
 Only two cases were heard. For the Chappels and David Vincent. The Board of Equalization requested the Chappels come back after more information had been obtained about them donating their parcel to Talbot County. The Board of Equalization acted on the David Vincent appeal and accepted the value that the Chief Appraiser recommended. The value was reduced based on the current condition of the mobile home. All other appeals are scheduled to be heard on 9/8/16.
- F. Budget Report Mrs. Harbin advised that the Board of Commissioners has not provided a current budget update.
- G. Homestead Applications Homestead applications for 2017 were presented for Norman Carter S1, Betty Richards S4, Donald Moran S4, Katie Antley S5, and Jon Battle S1. A motion was made by Ms. Cook to approve Homestead applications as presented Mr. Hale seconded the motion. There was no further discussion. The vote passed 2-0-0.
- H. Conservation Use A motion was made by Vice-Chairman Hale to approve the Conservation use applications & releases as presented by the Chief Appraiser. Ms. Cook seconded the motion. Carried 2-0-0 These applications were for continuations of existing covenants.
