# Board of Assessors Meeting Minutes April 10, 2017

## 1. MEETING CALLED TO ORDER BY THE BOARD OF TAX ASSESSORS

The meeting was called to order by Chairman Dan Coffee at 4:26 pm at the office of the Talbot County Board of Tax Assessors. A quorum was present including the following: Daniel B. Coffee, Leticia Cook, and Lauren A. Harbin, Secretary.

- 2. Ms. Cook made a motion to approve the March 13, 2017 and March 30, 2017 minutes as presented. Chairman Coffee seconded the motion. There was no discussion. The motion passed 2-0-0.
- 3. Ms. Cook made a motion to approve the agenda with no changes. Chairman Coffee seconded the motion. There was no further discussion. The motion passed 2-0-0.

## 4. A. Appearances-

- i. Mr. Daniel Woodson from Adaptive Home Improvements was scheduled to be on the agenda to discuss his 2016 assessment. Mr. Woodson expressed his concern over his value increase in 2016 and stated that he did not receive his 2016 assessment notice. He also expressed his discontent with the fact that a notice with such a large increase was only mailed first class mail and not certified. Chairman Coffee explained the appeal process and confirmed that Mr. Woodson was receiving mail at the address we had on file. Mrs. Harbin advised Mr. Woodson that the income approach could possibly be used if he provided income documents for the next assessment period, but that it was too late to make a return for 2017. The Board advised Mr. Woodson that the assessment for 2016 stands since the deadlines in accordance with Georgia Law have passed. He was reminded that his 2017 assessment would be mailed in May of 2017 and the Board explained the appeal rights the law provides to him
- ii. David Jordan appeared for Oliver Logging. He gave a brief synopsis of the issue with the 2016 personal property account. He stated that he felt the same thing applied for 2015, and asked the Board to issue a error and release for 2015 as well. The Board asked Mrs. Harbin to brief the Board on this matter. Mrs. Harbin stated that the issue had been discussed with Al Deen from M & W Consulting and Mr. Deens opinion was that the 2015 assessment was finalized as there was no appeal to the notice and the tax bill was paid. Ms. Cook and Mr. Coffee thanked Mr. Jordan for his time and said that they would discuss it further and be in touch.

#### 5. Old Business

A. Mrs. Harbin updated the Board as to the progress of the re evaluation, and stated that she felt the office was on track to mail assessments on or around May 15, 2017.

- D. Homestead Applications for 2017 Ms. Cook, and Chairman Coffee reviewed the homestead applications, and Ms. Cook made a motion to approve them as presented. Chairman Coffee seconded the motion. Mrs. Harbin informed the Board about the new legislation in HB 196 concerning the Veterans Exemption. Chairman Coffee and Ms. Cook advised Mrs. Harbin to follow it closely and once it was made law on July 1, 2017 to process proceed in accordance with the law. The motion carried 2-0-0.
